PROGRAM DESCRIPTION

The Senior Mobility and Safety (SMS) Action Team is part of a network of committees comprising local, state, federal and private partners, working in collaboration with the Governor's Traffic Safety Advisory Commission (GTSAC) to identify traffic safety challenges and comprehensive solutions. The focus of the Senior Mobility and Safety Action Plan is to reduce the rate of senior driver fatalities and serious injuries.

Safe Drivers Smart Options (SDSO): Keys to Lifelong Mobility is Michigan's statewide strategy to support the safe mobility of Michigan's aging adults. The overarching goals of the SDSO strategy are to: 1) help older adults who are able to drive safely continue to do so, 2) facilitate the transitioning process from driving to non-driving for those who are unable or choose not to drive, and 3) support the use of non-driving community mobility options for those who no longer drive.
